

## Declaration designating the person authorized to use the safe

**wich was concluded between on the one hand:**

on the other hand

jointly: **Parties —**

today, in the place and under the conditions set out below:

1. It is known to the parties that on ..... day the safe tenant and MGV Magyar Gazdaság- és Vállalkozásfejlesztő Zrt (registered office: H-1054 Budapest, Aulich u. 7, tax number: 24721617-2-41, company registration number: 01-10-047880, hereinafter: MGV Zrt ), a safe deposit box lease number ..... (hereinafter: the Contract) was concluded.
2. By signing this declaration, the Lessee shall designate ..... as the person entitled to use the Safe Deposit Box for the duration of ..... in accordance with Clause III of the Agreement.
3. By signing this declaration, the person authorized to use the safe accepts the marking and expressly states that he has read and received the Agreement, the relevant General Terms and Conditions and the Announcement in advance.
4. By signing this declaration, the person authorized to use the safe expressly declares that he / she accepts the Contract, the relevant General Terms and Conditions (GTC) and the Announcement and considers it binding on him / her.
5. The person authorized to use the safe takes note of the following:
  - A. A. The person authorized to use the Safe Deposit Box is identified and registered by MGV Zrt. The person entitled to use the Safe Deposit Box is entitled to handle the Safe Deposit Box for the period specified in point 2 after getting to know and accepting the Contract and the GTC, as well as identifying and registering them.
  - B. The Safe Tenant and the person entitled to use the Safe Deposit Box have the rights and obligations different from the legal relationship as set out in the GTC and the Contract. The provisions of the Contract and the GTC apply to the person entitled to use the Safe Deposit Box, as applicable. The only right of the person authorized to use the Safe Deposit Box is to manage the Safe Deposit Box, ie to use the Customer Key, to view the contents of the Safe Deposit Box, to place items in the Safe Deposit Box and to remove items in the Safe Deposit Box. All persons entitled to use the Safe Deposit Box are entitled to dispose of the items placed in the Safe Deposit Box, MGV Zrt. does not examine the scope of the provision, MGV Zrt. shall not be liable for any claims arising from the persons entitled to use the Safe Deposit Box.

The person authorized to use the Safe Deposit Box is obliged to immediately notify MGV Zrt. of the damage related to the safe deposit box service and of the loss or damage of the Customer Key.

- C. MGV Zrt. provides the Safe Tenant with a single Customer Key, which the person authorized to use the Safe Deposit Box is also entitled to use.
- D. The person authorized to use the safe
  - is not entitled to amend or terminate the Agreement, to make a legal declaration regarding the validity and scope of the Agreement,
  - is not entitled to initiate a forced opening, to participate in the forced opening - unless otherwise provided by the Tenant of the Safe Deposit Box,
  - is obliged to comply with the provisions concerning the Safe Tenant / Customer, as applicable, such as the rules on the use of the Safe Deposit Box and the Customer Key, provided that the person entitled to use the Safe Deposit Box is not liable for payment obligations under the Contract, except for damages,
  - is liable for full damages. The person authorized to use the Safe Deposit Box and the Safe Tenant are jointly and severally liable to MGV Zrt. for the compensation of the damage caused by them.
- E. 2. By signing this declaration, the Lessee shall designate ..... as the person entitled to use the Safe Deposit Box for the duration of ..... in accordance with Clause III of the Agreement.
- F. E. The Safe Tenant may withdraw the notification of the person authorized to use the Safe Deposit Box at any time during the term of the Agreement without giving reasons.
- 6. F. The Safe Tenant and the person authorized to use the Safe Deposit Box are obliged to fully agree with each other regarding the safe deposit box service, in particular the use of the Safe Deposit Box and the associated Customer Key, as well as the ownership of the placed objects.
- 7. 6. The person authorized to use the safe expressly accepts the conditions for the use of the safe set out in the Contract and the GTC. 7. A copy of the Agreement, the GTC and the Announcement are attached to this statement.
- 8. 8. This Declaration shall form an integral part of this Agreement.

This statement has been signed by the parties after reading and jointly interpreting it as being in accordance with their will and the business statements made in all respects.
