**STATEMENT OF RIGHTS REGARDING PERSONAL DATA PROCESSING**

**No. 3 of the Privacy Policy Annex**

We would like to inform you if MGV Magyar Gazdaság- és Vállalkozásfejlesztő Zártkörűen Működő Részvénytársaság (before the Commercial Court of the Capital City Court under registration number 01-10-047880, registered office: H-1054 Budapest, Aulich utca 7, CSO statistical number: 24721617-6492 : 24721617-2-41), Data Controller, who handles your personal data, as a natural person, you may exercise the following rights related to the protection / processing of your personal data in writing (either in a letter submitted to the Data Controller's registered office or sent to the Data Controller) within the framework of this application.

You can find more detailed information about your rights to the protection of your personal data and the handling of your personal data by the Data Controller than contained in this Statement, the knowledge of the Data Management Policy is a prerequisite for making this statement.

**STATEMENT**

I, the undersigned, note that Regulation (EU) No 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Regulation (EC) No 95/46 (General Data Protection Regulation) "GDPR") shall apply from 25 May 2018.

I, the undersigned, acknowledge that the protection of individuals with regard to the processing of their personal data under the GDPR is a fundamental right. Article 8 (1) of the Charter of Fundamental Rights of the European Union (Charter) and Article 16 (1) of the Treaty on the Functioning of the European Union (TFEU) state that everyone has the right to the protection of personal data concerning him or her.
